

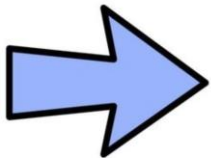

ACCREDITATION: MIDTERM REPORT

- A **Midterm Report** is required midway between comprehensive evaluation visits as specified in the Commission's Action letter (the College's is due **October 17, 2022**)
- **Commission Actions: Accept or Not Accept**
- **Purpose:** update the Commission on: 1) **ISER improvement plans**, 2) **improvement recommendations** made by the previous comprehensive peer review team, 3) **institutional performance** (student learning outcomes and institution-set standards; 1.B.2 and 1.B.3), and 4) **Quality Focus Projects**

PLANS ARISING FROM THE SELF-EVALUATION

1. Human Resources will develop a **list of review dates for APT evaluations** to remind supervisors of review deadlines for the 2018-19 year: **Completed** Fall 2018 with email reminders.
2. The College will create a **guide for orienting and mentoring lecturers** prior to the spring 2019 semester: **Ongoing**.
3. The Professional Development Coordinator will maintain an active **three-year campus professional development** plan that is visible to all employees of the College (beginning August 2018): **Completed** Fall 2018.
4. **Service outcomes** will be developed or revised for both the **Testing Center and Operations and Maintenance** prior to the fall 2018 semester: **Completed** Fall 2019 (Testing) and Fall 2021 (O&M).

PLANS ARISING FROM THE SELF-EVALUATION (Cont.)

5. The College's academic programs will **develop core sequencing plans for part-time students**, who are increasing at our college when compared to full-time students. This action item is directly related to one of our Quality Focus Essays, Scheduling for Success: **Ongoing**.
6. The College will dedicate a College Conversation and convene a student focus group to **develop strategies to increase student participation** in both student government and college committees during the 2018-19 year: **Completed** November 2021.
7. The College will use the current **Administrative Services survey** results to establish baseline target values for future surveys. The survey will be given every two years in the future, and used to inform the APRU. The next survey will be disseminated in 2019. **Completed** November 2021.

AREAS FOR IMPROVEMENT IDENTIFIED BY THE VISITING TEAM

- 1.** In order to improve institutional effectiveness, the College is encouraged to continue to improve the **transition to assessing of course learning outcomes through program learning outcomes** and to use the results to improve student learning and achievement (I.B.4): **Ongoing**.
- 2.** To improve effectiveness of **its online offerings**, the College should consistently apply the best practices articulated in College plans and documents, such as the KCC Distance Education Handbook (II.A.7): **Ongoing**.
- 3.** In order to improve institutional effectiveness, the team recommends that the System develop and implement an assessment process to measure the effectiveness of **role delineations, governance and decision-making processes** to ensure their integrity (IV.D.7): **Completed October 2021**.

REFLECTION ON IMPROVING INSTITUTIONAL PERFORMANCE: SLOs

Standard I.B.2: The institution defines and assesses student learning outcomes for all instructional programs and student and learning support services.

QFE #1: Scheduling for Success

- **Project goal was to examine course scheduling in terms of modality, location, time, days, length, etc.**
- **The desired outcome was to improve on-time degree completion and provide novel scheduling opportunities for working adults.**

QFE #2: Integrated Career and Integrated Services for Grades 11-14

- **Project goal was to develop a series of onboarding events.**
- **The desired outcome was to increase the number of high school students directly enrolling at KCC upon education with an educational goal.**

MIDTERM REPORT TIMELINE 2022

Spring 2022

- VCAA and ALO host two sessions at Welcome Back Week with faculty to reflect on improving institutional performance of **student learning outcomes for instructional programs** (January 2022)
- Complete evidence collection and draft report; **share draft with the campus** via College Council for review and feedback (January 2022)
- Incorporate **UHCC Recommendation for Improvement** into the draft report (January 2022)
- Present Midterm Report to **Student Senate** and seek feedback (February 2022)
- **Incorporate campus feedback** (via College Council) into the final draft of the report (February 2022)
- **Finalize draft** of report, validate links, and confirm evidence (March 2022)
- Chancellor host **College Conversation on Improving Institution Set Standards** and results will be incorporated into the final report (early April 2022)
- **Share final report with the campus** for review via College Council (late April 2022)
- Incorporate **final edits** into *2022 Midterm Report* (May/June 2022)

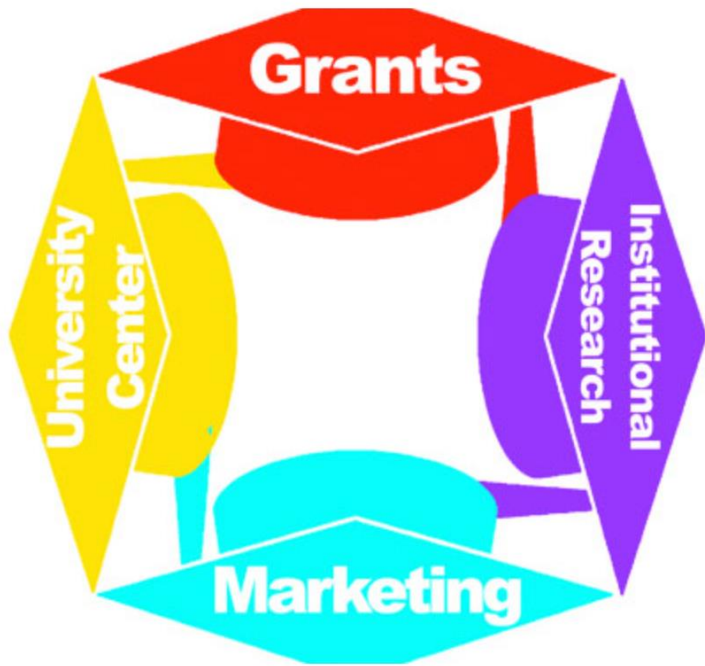
