

Federal Direct Unsubsidized Loan Request Form

Your initial 2018-19 Kauai Community College Financial Aid Award notification ONLY includes funds that are recommended for meeting the costs of your education. In many cases, KCC recommends not borrowing at all, or recommends borrowing amounts that are less than the annual loan limits.

Use this form to request a **Federal Direct Unsubsidized Student Loan** in addition to the funds already awarded and outlined in your initial 2018-19 financial aid award notification. If you have not requested and are eligible for a Federal Direct Subsidized Loan for the 2018-19 award year, you must complete an application for a Subsidized Direct Student Loan first.

<u>First Time Student Borrowers</u>: If this is your first Federal Direct Student Loan, you will need to complete and sign a *Master Promissory Note (MPN)* as well as *Entrance Counseling* prior to your loan being processed. Once completed, and upon receipt of this signed form, your loan will be processed.

<u>Please Note</u>: First time student, first time borrowers: There is a 30-day delay in the release of the first loan disbursement for first-time, first-year college students. (30 days AFTER the 1st day of the term).

<u>Transfer Student Borrowers</u>: If you have a borrowed a Federal Direct Student Loan at another college/university in the last 10 years, you **do not** need to do a new MPN. You must complete *Entrance Counseling* prior to your loan being processed. Once completed, and upon receipt of this signed form, your loan will be processed.
